Active Ingredient: Aluminum Zirconium Trichlorohydrex GLY

Inactive Ingredients: Cyclopentasiloxane, Dimethicone, Tribehenin, Petrolatum, Cyclodextrin, C18-36 Acid Triglyceride, Fragrance, Panthenyl Triacetate, Tocopheryl Acetate, Acetyl Glucosamine, PPG-14 Butyl Ether.

SECTION 4 - FIRST AID MEASURES
