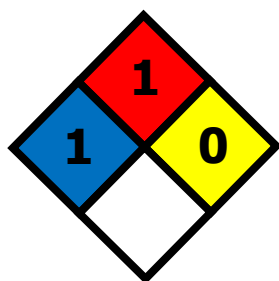

### 4. FIRST AID MEASURES

## 6. ACCIDENTAL RELEASE MEASURES

<b>Personal Precautions</b>	Use personal protective equipment. Avoid contact with skin, eyes, and clothing. Ensure adequate ventilation. If spilled, take caution, as material can cause surfaces to become very slippery.
<b>Methods for Containment</b>	Dike far ahead of liquid spill for later disposal.
