SECTION 4. FIRST-AID MEASURES

Description of first aid measures

Most important symptoms and effects, both acute and delayed

- : Causes serious eye damage. Symptoms may include severe pain, blurred vision, redness and corrosive damage. Harmful in contact with skin. Causes severe skin irritation. Symptoms may include redness, blistering, pain and swelling. May cause respiratory irritation. Symptoms may include persistent coughing, shortness of breath, coughing up blood and wheezing. SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures

- : All persons dealing with clean-up should wear the appropriate protective equipment including self-contained breathing apparatus. Refer to protective measures listed in sections 7 and 8. SECTION 7. HANDLING AND STORAGE

Precautions for safe handling

: Use only outdoors or in a well-ventilated area. Wear protective gloves/clothing and eye/face protection. Do not breathe mist or vapor. Avoid contact with skin, eyes and clothing. Keep away from heat and sources of ignition. Keep away from metals and incompatibles. No smoking in the area. When preparing or diluting solution, always add to water, slowly and with stirring. Use only non-sparking tools. Take precautionary measures against static discharge. Ground/Bond container and receiving equipment. When diluting, always add the product to water. Never add water to the product. Label containers appropriately. Keep containers tightly closed when not in use. Wash thoroughly after handling.

Conditions for safe storage : Store in a cool, dry, well-ventilated area. Store away from incompatibles and out of direct sunlight. Storage area should be clearly identified, clear of obstruction and accessible only to trained and authorized personnel. Inspect periodically for damage or leaks. No smoking in the area. Store in corrosion-resistant containers. Not corrosive to some stainless steels (e.g. types 304, 316). Copper and alloys, except those with high zinc content, show good resistance at all concentrations. High concentrations (> 99%) may be used with or stored and shipped in aluminum (alloys not specified). Aluminum slowly corrodes, forming a layer of aluminum acetate that prevents further corrosion. Water will increase the corrosion rate.

Incompatible materials : Alkalies; Strong oxidizing agents; Metals (Carbon steel; Brass; Zinc; bronze); Acetaldehyde.

Ventilation and engineering measures

: Provide exhaust ventilation or other engineering controls to keep the airborne concentration of vapours below their respective threshold limit value. Use explosion-proof electrical and ventilating equipment.
