Wash thoroughly after handling. Do no eat, drink or smoke when using this product. Wear protective gloves/protective clothing/eye protection/face protection. Keep container tightly closed in a cool, well-ventilated place. This material should be kept in an area suitable for the storage of flammable liquids.
