Steps to Take in Case Material Is Released or Spilled:

Gather and store in a sealed container pending a waste disposal evaluation. Ensure clean-up measures are in compliance with OSHA (29 CFR 1910.120). Use an inert absorbent such as sand or vermiculite. Place in properly labeled closed container. Isolate hazard area. Keep unnecessary and unprotected personnel from entering. Do not flush spill to drain.

Handling: Avoid breathing dust/fume/gas/mist/vapors/spray. Wash thoroughly after handling. Do not eat, drink or smoke when using this product. Use only outdoors or in a well-ventilated area.
