### Acute health effects

**Skin contact** Unlikely to cause skin irritation.

**Chronic health effects** Prolonged inhalation of excessive amounts of any dust may cause lung damage. Use of this product as intended does not result in inhalation of excessive amounts of dust.

## 6. Accidental Release Measures
