## 2. HAZARDS IDENTIFICATION SUMMARY

## 4. FIRST AID MEASURES

<b>If in eyes:</b>	Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

## 6. ACCIDENTAL RELEASE MEASURES

### STEPS TO BE TAKEN IF MATERIAL IS RELEASED OR SPILLED:

Avoid breathing vapors. Absorb and sweep up spills immediately and transfer to suitable containers for possible land application according to label use or for disposal. Check local, state and federal regulations for proper disposal.

**CAUTION:** Keep spills and cleaning runoff out of municipal sewers and open bodies of water.

**7. HANDLING AND STORAGE**

**HANDLING:** Flammable. Do not use or store near heat or open flame. Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

**STORAGE:** Avoid freezing. Store above 40°F / 5°C. If frozen, poor weed control may result. Flammable. Do not use or store near heat or open flame. Store in original container only. Do not contaminate water, food or feed by storage or disposal.

**10. STABILITY AND REACTIVITY**

**STABILITY:** Stable

**CONDITIONS TO AVOID:** Excessive heat or extreme cold; avoid freezing.

**INCOMPATIBILITY:** Strong bases and oxidizers.

**12. ECOLOGICAL INFORMATION**

This pesticide is toxic to fish and aquatic invertebrates. Do not apply directly to water, to areas where surface water is present or to intertidal areas below the mean high water mark. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. **Pressure rinse as follows:** Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip. Do not contaminate water, food or feed by storage or disposal.
