In Case of Fire

Use dry chemical, foam or CO2 extinguishing media. Wear full protective clothing and self-contained breathing apparatus. Evacuate nonessential personnel from the area to prevent human exposure to fire, smoke, fumes or products of combustion. 6. ACCIDENTAL RELEASE MEASURES

In Case of Spill or Leak

Control the spill at its source. Contain the spill to prevent from spreading or contaminating soil or from entering sewage and drainage systems or any body of water. Clean up spills immediately, observing precautions outlined in Section 8. Cover entire spill with absorbing material and place into compatible disposal container. Scrub area with hard water detergent (e.g. commercial products such as Tide, Joy, Spic and Span). Pick up wash liquid with additional absorbent and place into compatible disposal container. Once all material is cleaned up and placed in a disposal container, seal container and arrange for disposition.

Reproductive/Developmental Effects

Fludioxonil: Delayed development at doses causing maternal toxicity.

Thiamethoxam: Developmental: Not teratogenic in rats or rabbits.

Reproductive: No effects on reproduction. Minor increase in a common testis effect in rats at high doses, which did not affect reproduction. When used in accordance with label directions and recommendations in this SDS, no effects would be expected in humans.

Chronic/Subchronic Toxicity Studies

Fludioxonil: Liver and kidney toxicity at high dose levels.

Thiamethoxam: Subchronic: Liver effects occurred in rodents only at high dose levels. Not neurotoxic after high acute and subchronic exposure in rats.

Carcinogenicity

Fludioxonil: Marginal increase (7%) of liver tumors (female, rats: 3,000 ppm); Within historical control range (1 to 10%).

Thiamethoxam: Classified as "not likely to be carcinogenic in humans" based on lifetime studies in mice and rats.

Glycerin
