and place in a disposable container. After removal, flush contaminated area thoroughly with water. This material should be prevented from contaminating soil or from entering sewage and drainage systems and bodies of water.

**SECTION 7: HANDLING AND STORAGE**

**HANDLING AND STORAGE:** Read label carefully before use. Avoid contact with skin, eyes or clothing. Avoid breathing spray mist. Wash hands thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco, or using the toilet. Remove clothing immediately if pesticide gets inside.
